A certified housing counselor may also assist homeowners with negotiating a repayment plan, securing a loan modification or other possible solutions that will allow the homeowner to retain homeownership. Our mission to strengthen the well-being of individuals and families through education, guidance, advocacy and support conveys the compassionate guidance we provide to individuals and families as we address the needs of community residents, including economic development, human services and education programs. Personal financial counseling is provided by certified counselors. A complete budget analysis is prepared for consumers experiencing budget, credit or debt related concerns. One on one counseling assesses the consumer's monthly financial profile and facilitates guidance to resources. Our counseling model includes a thorough budget analysis and the development of an action plan supported by resources, recommendations and education material. During the period, we provided over 39,000 counseling sessions and distributed over 9,000 pieces of education material per month, excluding material distributed as part of our community outreach work and via our website.

Debt Management Program We administer a Debt Management Program (DMP) for those individuals who require assistance in managing their finances and unsecured debt.
