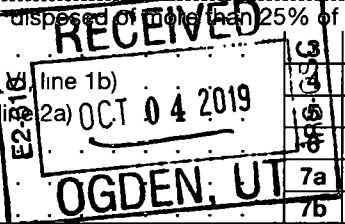

The President of the Board of Directors and the Executive Director are sisters

The annual Form 990 is first reviewed and approved by management. It is also subsequently reviewed and approved by the Board of Directors at the next scheduled board meeting, which may or may not occur before the due date for filing the Form 990

The Board of Directors annually meet to discuss and approve the Executive Director's annual compensation. Factors that are discussed in determining compensation include performance, years of service, and comparable salaries of executive directors of other similar organizations

The organization generally does not make its governing documents, conflict of interest and financial statements available to the public.
