IT IS THE POLICY OF CCBC AND ITS STAFF TO PROVIDE MEANINGFUL PERSONAL FINANCIAL EDUCATION AND COUNSELING THAT MEETS OR EXCEEDS CUSTOMER REQUIREMENTS AND TO ENHANCE MEASURABLY, THROUGH OUTREACH ACTIVITY, THE ECONOMIC WELLNESS OF COMMUNITIES SERVED.

CCBC HAS EXPANDED ITS ABILITY TO PROVIDE FINANCIAL EDUCATION TO OUR NATION'S MILITARY MEMBERS AND VETERANS THROUGH ITS WARRIOR SUPPORT SERVICES DIVISION. THE WARRIOR SUPPORT SERVICES DIVISION FOCUSES ON THE FINANCIAL LITERACY EDUCATIONAL NEEDS OF U.S. MILITARY VETERANS AND ACTIVE DUTY MEMBERS THROUGH PROGRAMS PARTNERSHIPS WITH GROUPS SUCH AS THE YELLOW RIBBON PROGRAM AND RETURNING WARRIOR WORKSHOPS. THESE PARTNERSHIPS, IN COMBINATION WITH CCBC'S PROGRAMS ARE AT PART OF A NATIONWIDE COHESIVE APPROACH WHOSE PRIMARY FOCUS IS TO IMPROVE THE FINANCIAL LITERACY OF OUR MILITARY AND THEIR FAMILIES AND TO HELP THEM IDENTIFY RESOURCES AVAILABLE IN THEIR COMMUNITIES TO HELP THEM WITH THEIR SPECIFIC FINANCIAL NEEDS BY COMBINING IT'S RESOURCES WITH THESE OTHER LEADING NATIONAL NON-PROFIT ORGANIZATIONS. CCBC HAS THE ABILITY TO HELP FAMILIES THAT ARE LOOKING TO TAKE RESPONSIBILITY FOR THEIR PERSONAL FINANCES AND MAKE BETTER, MORE INFORMED DECISIONS IN THE FUTURE.
