Provide vocational education to residents of Philadelphia who are unable to pay community college tuition or other expenses of training to allow such residents to develop or advance in a career.

Dental assistant training was provided to four students on a tuition-free basis. Three students completed the training. Training prepares students for an entry level position in the fast-growing health-care field with a curriculum introducing the student to the profession of dentistry and each of its recognized specialties. The student learns all areas of pre-clinical dental assisting and receives training in the professional skills required to assist in a dental practice. Coursework includes lecture and laboratory sessions. Training includes legal aspects of dentistry, policies and guidelines, oral and dental anatomy, infection control, radiology theory, and instrument identification and use. Training prepares students to sit for all three components of the Certified Dental Assistant DANB exams: Radiation Health and Safety (RHS), Infection Control (ICE), and, upon completion of the clinical hours requirement, the General Chairside exam (GC). Wanamaker Institute covers all fees for the RHS and ICE certification exams and for a review course for the National Entry Level Dental Assistant exam.

4b (Code:) (Expenses \$ 9,682 including grants of \$) (Revenue \$)

Training was provided to ten students to become personal trainers. Training includes both coursework and clinical instruction with a goal of allowing the student to pass a certification exam and develop his or her own personal training business. Personal training has been identified as a potential source of employment for ex-offenders re-entering society. Wanamaker Institute implemented this training course in an effort to assist such ex-offenders and others who could no afford the necessary training to allow such individuals to pursue a path toward a potential career.

4c (Code:) (Expenses \$ 8,578 including grants of \$) (Revenue \$)

Pharmacy technician training was provided to fifteen students, eleven of whom completed the training course, eight of whom took the certification exam, and four of whom passed the certification exam on the initial try. The training includes initial screening and testing, course instruction, textbooks and supplies and certification exams. In addition, students completing the training and exam were placed in 40-hour externships with Walgreen Pharmacies in Philadelphia, with the hope of leading to full-time employment.
