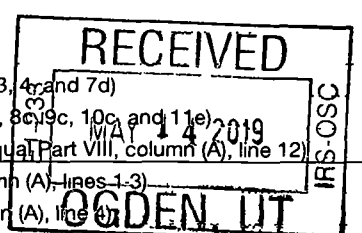

The Wanamaker Institute provides vocational education to residents of Philadelphia who are unable to pay community college tuition or other expenses of training to allow such residents to develop or advance in a career.

The Institute offered a Child Development Associate program to twenty underemployed child care workers to allow them to achieve certification as a child development associate. Coursework is an integral part of developing a portfolio for submission to the Council for Professional Recognition, which is required to register for the credentialing exam. The course and the portfolio are the baseline for nationwide credentialing which can lead to better employment opportunities.

4b (Code) (Expenses \$ 5,600. including grants of \$) (Revenue \$)

Nurse aide training was provided to eight students. Coursework is intended to prepare students to take the Pennsylvania Nurse Aide Competency and Training Examination and begin a career in healthcare as a nurse aide.

4c (Code) (Expenses \$ 7,000. including grants of \$) (Revenue \$)

The Institute provided a CNC Precision Machining training program to two students to advance their careers in manufacturing. CNC (or Computer Numerical Control) Precision Machining is a widely used technique for producing a variety of complex parts and components with a high degree of accuracy. The program is intended to train students for a career in a growing industry in the City of Philadelphia and nationwide with potential for a higher than average salary. Training programs tend to be higher cost and beyond the reach of most lower income students.
