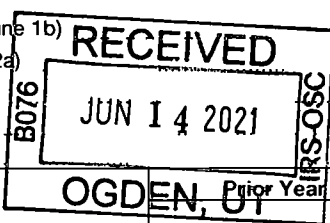

The Institute provided a Child Development Associate program to nineteen underemployed child care workers to allow them to achieve certification as a child development associate. Coursework is an integral part of developing a portfolio for submission to the Council for Professional Recognition, which is required to register for the credentialing exam. The course and the portfolio are the baseline for nationwide credentialing which can lead to better employment opportunities.

4b (Code) (Expenses \$ 14,359. including grants of \$) (Revenue \$)

The Institute provided programs for 9 nurse aides and nursing students to train low income residents of Philadelphia for the many nurse aide and nursing positions available in the extensive Philadelphia health care industry. Nurse aide programs include classroom lecture, lab skills and clinical practicum to prepare the student for employment in long-term care facilities, hospitals and nursing homes. Training topics include the role and function of a nurse aide, resident rights, nutrition, abuse and neglect prevention, infection control, psychosocial needs, safety and accident prevention, personal care skills, communication skills, and legal and ethical aspects of long-term care. Participants will be prepared to sit for the Pennsylvania State Nurse Aide Competency and Training Examination upon

4c (Code) (Expenses \$ 6,186. including grants of \$) (Revenue \$)

The Institute provided a dental assistant program for three students. The program is designed to teach students how to play a critical role as part of a dental health care team that educates and treats patients. Students are trained to provide preventative care and treatment, which may include medical and dental history review, head and neck examination, exposure of dental radiographs (x-rays), dental prophylaxis (teeth cleaning), fluoride, sealants and polishing of restorations. Students use state-of-the-art equipment, have access to faculty who are experts in the dental hygiene profession, benefit from supervised, hands-on experience with patients, and receive excellent preparation to move on to a career as a licensed and certified dental hygienist.
