EDCNP's development assistance resulted in 383 jobs being retained or created. EDCNP counseled 303 entrepreneurs and small businesses. EDCNP assisted 65 businesses in various aspects of exporting and acquired 14 new clients. Companies reported 149 export actions and 15 clients reported \$53,417,846 in export sales and 521 jobs retained or created

Planning, Government & Community Assistance - During the past year EDCNP provided comprehensive transportation planning, government & community development support, GIS and research assistance within the region. The Transportation Services Division maintains the Transportation Improvement Program (TIP) for the NEPA Metropolitan Planning Organization (MPO), maintained & initiated an update of the MPO's Long Range Transportation Plan, updated the regions' Transportation Improvement Program (TIP), completed a strategic plan for the MPO, provided infrastructure asset mapping & GIS support, administered the Focus 81 committee, managed the Local Technical Assistance Program (LTAP) which provides technical training for elected & municipal officials & road maintenance crews, & administered the Back Mountain Community Partnership which focuses on municipal cooperation. The Community & Economic Development Services Division operates a nonprofit assistance center, research & information center, a Community Development Entity, the Blue Ribbon Task Force, the NEPA Grantmakers Forum and maintains the Comprehensive Economic Development Strategies (CEDs). EDCNP provided economic impact modeling services, grant seeking & writing training services & technical assistance related to ARC & EDA grants for local governments & nonprofits.
