THESE PROPOSED WAGES FOR EACH INDIVIDUAL ARE APPROVED BASED UPON THE LESSOR OF THE AMOUNTS NEGOTIATED AND APPROVED BY THE COUNTY OF LEBANON OR THE AMOUNTS SPECIFIED IN 55 PA. CODE CHAPTER 4300, SECTION 4300.83 (B) AND (C).
