BRIDGE HOUSING IS A REHABILITATIVE HOUSING PROGRAM WHICH ALLOWS A LONGER-TERM OPTION (UP TO ONE YEAR), PROVIDING MORE TIME FOR HOMELESS FAMILIES TO HONE BASIC LIVING SKILLS, GETTING THEM ON TRACK FOR A SUCCESSFUL INDEPENDENT LIVING. THE BRIDGE HOUSING UTILIZES EIGHT APARTMENT UNITS IN YORK CITY AND TWO UNITS ON THE THIRD FLOOR OF A BELL FAMILY SHELTER.
