ALL OTHER ASSISTED LIVING PROGRAMS PROVIDE, FURNISH, AND MAINTAIN SUITABLE LIVING QUARTERS, FACILITIES AND SERVICES FOR DISADVANTAGED INDIVIDUALS AND FAMILIES, PRIMARILY THOSE WHICH ARE MENTALLY AND EMOTIONALLY DISABLED. THIS PROGRAM INCLUDED THE BELL SHELTER AND BRIDGE HOUSING. THE BELL SHELTER IS A FAMILY SHELTER WHICH PROVIDES LIVING QUARTERS FOR FAMILIES FOR UP TO 30 DAYS AND CURRENTLY HAS CAPACITY FOR ABOUT 40 PEOPLE PER NIGHT. BRIDGE HOUSING IS A REHABILITATIVE HOUSING PROGRAM WHICH ALLOWS A LONGER-TERM OPTION (UP TO ONE YEAR), PROVIDING MORE TIME FOR HOMELESS FAMILIES TO HONE BASIC LIVING SKILLS, GETTING THEM ON TRACK FOR A SUCCESSFUL INDEPENDENT LIVING. THE BRIDGE HOUSING UTILIZES EIGHT APARTMENT UNITS IN YORK CITY AND TWO UNITS ON THE THIRD FLOOR OF A BELL FAMILY SHELTER.
