THE COUNSELING DEPARTMENT PROVIDES SUPPORT TO VICTIMS OF DOMESTIC AND SEXUAL VIOLENCE AND THEIR FAMILIES IN UNDERSTANDING THE DYNAMICS AND EFFECTS OF ABUSE. IN FY 2018-2019, SAFE BERKS PROVIDED 5,467 HOURS TO 1,337 VICTIMS, 1,056 HOURS OF COUNSELING TO 224 CHILDREN AND 115 HOURS (208 INDIVIDUALS) COUNSELING FOR SIGNIFICANT OTHERS OF VICTIMS. ADDITIONALLY, 463 CALLS FOR IMMEDIATE CRISIS RESPONSE WERE HANDLED. THE COUNSELING SERVICES PROGRAM IS FREE, AND AVAILABLE IN ENGLISH AND SPANISH. THE TRANSITIONAL HOUSING PROGRAM PROVIDES HOUSING TO ASSIST WOMEN AND CHILDREN WITH AN OPPORTUNITY TO START OVER, BY LEARNING HOW TO BE ON THEIR OWN, MAKING THEIR OWN DECISIONS AND SECURING A NEW HOME. THE PROGRAM ASSISTS VICTIMS OF DOMESTIC AND SEXUAL VIOLENCE BY PROVIDING INSTRUCTION IN LIFE AND MONEY MANAGEMENT SKILLS, CREATING A SAFE ENVIRONMENT, BUILDING SELF-ESTEEM AND SELF-AWARENESS, AND UNDERSTANDING THE EFFECTS OF DOMESTIC AND SEXUAL VIOLENCE. THE PROGRAM ALSO PROVIDES INDIVIDUAL CASE MANAGERS, ALONG WITH SUPPORT AND HOUSING MEETINGS.
