The ELECT program provides prenatal, parenting, life-skills and prevention education to teens and young adults ages 13-26 through ELECT Teen Parenting and Community Education programs. MCC has developed considerable expertise in providing direct services that address the needs of at-risk pregnant and newly parenting women and their young children. Our most recent agency-wide outcomes demonstrate a substantial impact on the health and wellbeing of our clients: 68% of clients enrolled in MCC's home visiting programs reduced their risk for perinatal depression; 84% of clients initiated breastfeeding (compared to 49% of Philadelphia WIC participants); and 92% of clients practiced safe sleep by placing their babies to sleep on their backs (compared to 65% of PA women). The policy and research departments provide education for the public, professionals, researchers and policy-makers regarding emerging and critical maternal child health and early care and education issues.
