AS AN INFORMATION RESOURCE, THE ALLIANCE HOSTS INNUMERABLE WORKSHOPS, CONFERENCES, WEBINARS AND PROGRAMS THROUGHOUT THE YEAR THAT REACH PEOPLE STATEWIDE TO BUILD THE CAPACITY OF THE INDUSTRY.
