Working closely with Magee since its founding as the first Medical-Legal Partnership in Philadelphia and one of the first in the nation, LCD is unique as the only organization in the five-county Philadelphia region that is dedicated exclusively to providing direct legal services tailored to the needs of persons with physical disabilities. In 2015, LCD provided direct representation, extended service, advice and referral to over 900 people. In 2010, LCD underwent strategic planning with a focus on program development, board development, governance and fundraising.
