JCHAI OPERATES THREE GROUP HOMES FOR ADULTS (ONE EACH IN WYNNEWOOD, ELKINS PARK, AND NORTHEAST PHILADELPHIA) WITH A MILD TO MODERATE INTELLECTUAL DISABILITY DIAGNOSIS, AUTISM, OR TRAUMATIC BRAIN INJURY, AS WELL AS A SUPPORTIVE LIVING APARTMENT PROGRAM FOR HIGHER FUNCTIONING ADULTS WITH A SIMILAR DIAGNOSIS. THE RESIDENTS WHO LIVE IN THESE HOMES AND APARTMENTS LEARN TO LIVE ALMOST INDEPENDENTLY, HOLDING GAINFUL EMPLOYMENT, LEARNING TO COOK AND CLEAN, TAKE PUBLIC TRANSPORTATION, AND SOCIALIZE WITHIN THE COMMUNITY. ALTHOUGH A NON-SECTARIAN ORGANIZATION, JCHAI ALSO PROVIDES JEWISH PROGRAMMING FOR THOSE RESIDENTS WHO WISH TO PARTAKE IN THOSE ACTIVITIES. THE HOMES ARE KOSHER, AND MANY SYNAGOGUES LOCAL TO THE HOMES HELP RESIDENTS CELEBRATE THEIR JEWISH HERITAGE. CURRENTLY, JCHAI HAS 70 RESIDENTS AND CLIENTS IN JCHAI AT HOME.
