JCHAI OPERATES A SUPPORTIVE LIVING APARTMENT PROGRAM AT THE RADWYN APARTMENTS IN BRYN MAWR FOR ADULTS WITH INTELLECTUAL DISABILITIES OR AUTISM, WHICH PROVIDES STAFFING TO ASSIST WITH DAILY LIVING ACTIVITIES, VOCATIONAL TRAINING, TRAVEL TRAINING, AND HELPING CLIENTS ACCESS COMMUNITY OFFERINGS THE WAY NEUROTYPICAL PEOPLE ARE ABLE TO. JCHAI ALSO HAS THREE HOMES IN THE COMMUNITY THAT ARE OPERATED ON A SIMILAR BASIS. THE CLIENTS WHO LIVE IN THESE SETTINGS HOLD COMPETITIVE, INTEGRATED EMPLOYMENT AT A RATE DOUBLE THE NATIONAL AVERAGE, LEARN TO TAKE CARE OF WHERE THEY LIVE, COOK, TAKE PUBLIC TRANSPORTATION AND SOCIALIZE IN THE COMMUNITY. JCHAI IS NON-SECTARIAN, BUT ALSO PROVIDES JEWISH PROGRAMMING ON AN OPTIONAL BASIS. JCHAI HAS ABOUT 40 CLIENTS IN THESE SERVICES.

JCHAI ALSO PROVIDES INDEPENDENT LIVING SERVICES, KNOWN AS JCHAI AT HOME, AND A YOUNG ADULT EDUCATIONAL PROGRAM, KNOWN AS JCHAI TRANSITIONS FOR ADULTS WITH INTELLECTUAL DISABILITIES OR AUTISM WHO LIVE WHERE THEY WISH IN THE COMMUNITY. JCHAI STAFF SPENDS SEVERAL HOURS A WEEK HELPING THE CLIENTS WITH ACTIVITIES OF DAILY LIVING, INCLUDING GROCERY SHOPPING, BANKING, AND PERSONAL HYGIENE AND SOCIALIZATION, ALL ON AN INDIVIDUALIZED BASIS. JCHAI TRANSITIONS PROVIDES EARLY EVENING WEEKDAY CLASSES AND WEEKEND OUTINGS FOR YOUNG ADULTS, AIMED AT INCREASING SOCIALIZATION AND TEACH INDEPENDENT LIVING AND VOCATIONAL SKILLS. THESE PROGRAMS COMBINED HAVE ABOUT 110 CLIENTS.
