PROGRAMS FOCUS ON COMMUNITY LIVING, VOCATIONAL SKILLS, DAILY LIVING ACTIVITIES, AND SOCIALIZATION.

THIS PROGRAM ENCOURAGES A SMOOTH TRANSITION FOR THE MEMBERS SO WHEN THEY FINISH HIGH SCHOOL, THEY ARE MORE PREPARED TO LIVE AND WORK A SUPPORTED, INDEPENDENT LIFE. TRANSITION MEMBERS GET TO SEE THAT IT IS POSSIBLE TO LIVE AWAY FROM THEIR PARENTS BECAUSE MANY PROGRAMS AND CLASSES ARE TAUGHT WITH JCHAI MEMBERS WHO ALREADY LIVE IN OUR SUPPORTED APARTMENTS OR AT HOME PROGRAMS.
