The Philadelphia Children's Alliance is an independent non-profit organization that promotes healing and justice for sexually abused children in Philadelphia Using a multidisciplinary approach, we collaborate with our partners in child protection, law enforcement, and medical and mental health services to provide forensic interviews, victim support and counseling services at the Philadelphia Safety Collaborative, a co-located child-friendly facility We are committed to using best practices and we promote this model locally and nationally In FY 2016, PCA provided forensic interviews to 2,079 children and 1,977 caregivers received victim support services In addition, 119 children received therapy and 305 children received on-site medical evaluations
