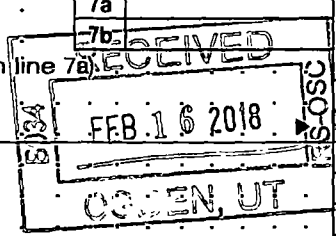

Part V, Question 34. Pro Bono Partnerships, Inc., had been dormant for many years. It was reactivated in the fall of 2017 to serve as the non-profit subsidiary of the Wayne County (PA) Bar Association with regard to the delivery of no-fee legal services to the poor in the areas of child custody and domestic abuse. Accordingly, the corporation's bylaws were amended to reflect the new ex officio members of the Board of Directors and Treasurer of the corporation, as well as its new purpose. On October 10, 2017, it filed Form 1023 seeking reinstatement of its 501(c)(3) status, which was granted by IRS determination letter dated December 14, 2017. The corporation will commence operations serving its new purpose in 2018.
