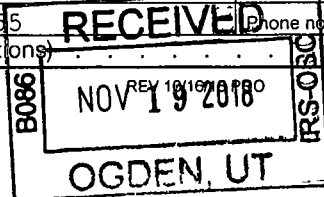

PACDC's key accomplishments of the fiscal year included: POLICY & ADVOCACY \*Philadelphia Housing Trust Fund: PACDC continued efforts to at least double dedicated revenue to the Philadelphia Housing Trust Fund (HTF) to \$25 million per year to expand affordable housing opportunities for low- and moderate-income residents through the development of new affordable homes, repair and preservation of occupied homes, and homelessness prevention. As a result of our campaigns, "Can't Wait to be Home: Double the Housing Trust Fund", and "Affordable Homes for a Growing Philly", City Council approved a new Mixed Income Housing policy for the city and new funding sources projected to raise an additional \$20+ million per year for the HTF. Since its inception, the HTF has assisted more than 40,000, 80% of which earned 30% of See Part III, Ln 4a statement
