THE AGENCY PRESENTED TWO WORKSHOPS ON FINANCIAL LITERACY TOPICS IN THE FIRST 8 MONTHS OF THE YEAR: INSURANCE INS AND OUT, AND JOB SEARCH SKILLS. NORTH STAR WAS ALSO HEAVILY INVOLVED IN THE PLANNING AND PRODUCING OF THE CHESTER COUNTY SINGLE MOTHERS' VIRTUAL ONLINE CONFERENCE IN APRIL, WHICH INCLUDED SESSIONS ON MANAGING FINANCES IN A PANDEMIC, JOB SEARCH SKILLS, COOKING, AND SELF CARE TO MORE THAN 50 SINGLE MOTHERS WHO TUNED IN. NORTH STAR ALSO SUPPORTED CHILDREN OF PROGRAM PARTICIPANTS, BY DISTRIBUTING DONATED WINTER COATS, SCHOOL SUPPLIES, AND CHRISTMAS GIFTS, AND BY PAYING AN AVERAGE OF 210 EACH FOR 6 CHILDREN TO ATTEND CAMP/SUMMER CARE OR PARTICIPATE IN EXTRACURRICULAR ACTIVITIES. THIS EXPENSE WAS LOWER THAN NORMAL DUE TO CLOSURE OF MANY CAMPS AND DAYCARES DURING THE STATE CORONAVIRUS PANDEMIC LOCKDOWN.
