THIS FRESH START PROGRAM OFFERED 105 TRANSITIONAL HOUSING BEDS TO VETERANS AS WELL AS CASE MANAGEMENT AND OTHER SUPPORTIVE SERVICES TO 316 VETERANS IN FY18. THE PROGRAM WELL EXCEEDED THE MANDATED VA OUTCOME TARGET OF 65% OF VETERANS DISCHARGED MOVED ONTO PERMANENT HOUSING PLACEMENTS WITH 80% OF ALL VETERANS IN THE FRESH START PROGRAM MOVING TO PERMANENT HOUSING. ONLY 3.3% OF ALL VETERANS DISCHARGED WERE FOR DISCIPLINARY REASONS OR LEFT THE PROGRAM AGAINST ADVICE (VA TARGET WAS 23%), AND 16.7% OF THE VETERANS DISCHARGED WERE PLACED IN HIGHER LEVELS OF CARE. 85% OF ALL VETERANS WHO WERE ABLE TO WORK WERE EMPLOYED AT DISCHARGE (VA TARGET WAS 50%). BASED ON THESE FY18 ACCOMPLISHMENTS AND OUR FY18 VA GPD GRANT APPLICATIONS THE PROGRAM WAS AWARDED ADDITIONAL FUNDING THROUGH FY19.

THIS FRESH START RECOVERY HOUSING PROGRAM CONSISTED OF 63 BEDS FUNDED BY THE PHILADELPHIA OFFICE OF ADDICTION SERVICES (OAS). THE PROGRAM SERVED 332 ADULT MEN AND WOMEN IN FY18 AND WAS RECOGNIZED BY OAS AS A PROGRAM THAT CONSISTENTLY PROVIDES SERVICES AT A HIGH STANDARD. FRESH START HAS ALSO FORMED A WORKING PARTNERSHIP WITH THE NHS PARKSIDE RECOVERY PROGRAMS. MANY OF THE MEN AND WOMEN RESIDING IN THE FRESH START RECOVERY HOMES HAVE CHOSEN TO ATTEND PARKSIDE RECOVERY FOR INTENSIVE OUTPATIENT OR OUTPATIENT RECOVERY SERVICES. THIS PARTNERSHIP HAS IMPROVED OUTCOMES, RETENTION, AND THE UTILIZATION OF SERVICES AT BOTH FRESH START AND PARKSIDE RECOVERY IN FY18.

THE FRESH START VETERANS MOBILE CARE COORDINATION PROGRAM WORKED WITH VETERANS IN NEED OF HOUSING, INCOME, EMPLOYMENT, AND ACCESS TO MEDICAL AND MENTAL HEALTHCARE. THE PROGRAM RECEIVED A GRANT FROM THE PA VETERANS' TRUST FUND AND SERVED OVER 60 VETERANS IN FY18. ALL 60 OF THESE VETERANS ACHIEVED THEIR CASE MANAGEMENT GOALS AND WERE PLACED IN SAFE SUSTAINABLE HOUSING ARRANGEMENTS. 52 OF THE 60 VETERANS ENROLLED IN THE PROGRAM GAINED ACCESS TO VA AND COMMUNITY BASED MEDICAL AND/OR MENTAL HEALTHCARE AND 67% HAD ACQUIRED AN INCOME WHILE 22% HAD INITIATED THEIR VA BENEFITS CLAIMS. THE PROGRAM WAS EXTREMELY SUCCESSFUL AND SERVED APPROXIMATELY 25 MORE VETERANS THAN THE NUMBER OF VETERANS WE PROPOSED TO SERVE IN OUR FY18 PA VETERANS' TRUST FUND GRANT APPLICATION.
