PILP REPRESENTED 3 BLACK MEN WHO WERE PLACED IN SOLITARY CONFINEMENT AT LEBANON COUNTY JAIL FOR REFUSING TO CUT OF THEIR DREADLOCKS DUE TO RELIGIOUS REASONS. DURING LITIGATION, THE JAIL REVISED ITS POLICY AND LET THE MEN OUT OF SOLITARY CONFINEMENT. PILP ALSO CONTINUED TO ADDRESS THE HORRIFIC CONDITIONS OF CONFINEMENT AT THE UNITED STATES PENITENTIARY ("USP") AT LEWISBURG, THROUGH TWO ONGOING CLASS ACTIONS.
