NEW MARKETS TAX CREDIT (NMTC) PROGRAM PIDC CC supports high impact, transformational projects through the NMTC program. The NMTC program is a federal tax credit program designed to generate private-sector capital investment in low income areas. The program permits individual and corporate tax payers to receive credit against their federal income taxes for making qualified equity investments in projects that finance community development, stimulate growth and create jobs. 2018 was another significant year for the NMTC program, as PIDC CC invested \$44.6 million in high impact community revitalization projects. We invested in anchor projects like New Market West, a West Philadelphia community services and retail complex, the restoration of the historic Philadelphia Metropolitan Opera House on North Broad Street, transformation of the historic Bok Vocational High School into a community focused hub for small businesses and nonprofits in South Philadelphia, the expansion of Esperanza Health Center to a new facility in Kensington, and the renovation of a former East Kensington carpet Mill into Huntington Mills- a vibrant mixed use residential and commercial building. The Impact Development Fund is an innovative use of NMTC to finance neighborhood development projects and businesses in low income communities. PIDC CC lent \$5.8 million to five borrowers in five different neighborhoods during 2018.

PIDC Community Capital and its subsidiaries are required to file tax returns with the Internal Revenue Service (IRS). Income tax returns are subject to examination by the IRS for a period of three years. While no income tax returns are currently being examined by the IRS, tax years since 2015 remain open.
