Our counseling and training programs primarily target the multi-cultural, urban working class neighborhoods of North Philadelphia. At the heart of our outreach are our outpatient, faith-based counseling services. These services carefully blend traditional, Western counseling techniques such as Cognitive Behavioral Therapy and grounding techniques from Dialectical Behavioral Therapy, etc with a pastoral approach. The delivery of this unique care model, which was born in the Hispanic community and has been delicately tailored for the urban context has proven to be an effective therapy for PTSD, depression, anger, and anxiety, etc. In 2017, 142 individuals and families received a combined 1404 counseling appointments with our clinicians

Our efforts to train and inform the wider community on basic mental health topics represents a targeted upstream approach to public health, primarily consisting of 1) increasing mental health education and awareness through participation in grassroots events, and 2) offering intensive training to community lay-leaders through the delivery of our eight core curriculum training modules, which developed organically out of what our Co-Founder, Elizabeth Hernandez, D Min observed to be the dominant themes recurring in our counseling work. In 2017, while we underwent our first ever transition in leadership and prepared for expanded community outreach activities in 2018-19, our participation in grassroots, community events was extremely limited. In spite of the transition however, we were still able to conduct a full training series for a local church who sent 5 participants
