COUNSELING SERVICES Refuge's counseling program primarily targets the multi-cultural, urban, working-class neighborhoods of North Philadelphia. While there are several faith-based, outpatient treatment programs in Southeastern Pennsylvania, Refuge is the only faith-based counseling for adults in our region credentialed to accept Medicaid funds. At Refuge, a sensitive, pastoral counseling approach tailored to the urban context forms the basis of our intervention and these foundational principles are coupled with trauma-focused and evidence-based counseling techniques. Cognitive Behavioral Therapy, Dialectical Behavioral Therapy, and other traditional therapies are carefully integrated into each person's treatment plan. Our model of care was born in the Hispanic community and has been extended to African Americans, Caucasians and immigrant families living throughout North Philadelphia. We treat diagnosed conditions such as depression, PTSD, anxiety, anger, and Bipolar Disorder. OUTCOMES In 2019, 86 individuals and families received a combined 765 counseling appointments

TRAINING AND EDUCATIONAL OUTREACH Beyond its counseling services, Refuge also works to improve public health by training the local community on basic mental health topics. These grassroots efforts increase mental health education and awareness at the local level. The activities primarily consist of 1) workshops on basic mental health topics offered to small groups of lay-leaders & professionals, and 2) consultation for local pastors and members of their fellowships. Activities also include participation in panel discussions, hosting information tables at community fairs, and conducting free, brief, on-the-spot mental health screenings at grassroots public health events. OUTCOMES In 2019, 32 individuals received training at 3 workshops, and no community outreach events were conducted while extensive recalibration efforts were undertaken

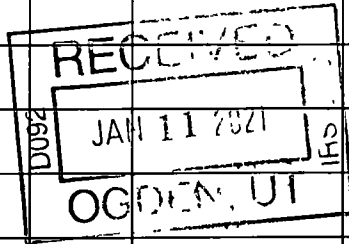

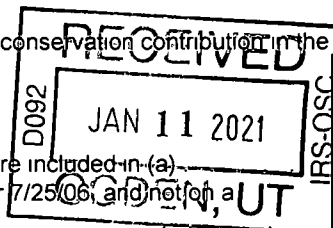

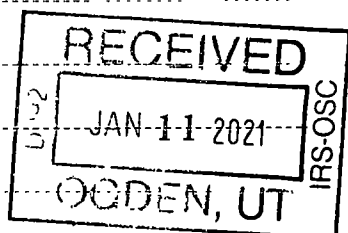
