CCA seeks and support solutions/initiatives aimed at breaking pervasive poverty among socioeconomically vulnerable populations through technical assistance, collaborative projects, and applied poverty research. CCA's technical support include projects designs, business plans, and program development, among others. We help organize CDFIs and STEM education projects, including Pre-K/after school programs, loan funds, training and workshops, among others.

 Technical Assistance: In collaboration with Beneficial Bank, Liberian Ministers Association, Multicultural Community Family Services and others, CCA provided support to organize a CDFI-loan fund among the African immigrant populations in the 5-county Philadelphia region. Further, CCA provided technical assistance to Called To Serve CDC, Multicultural, Faith Immanuel Lutheran, New Direction Fellowship and others - in the specific areas of project designs, business plan for childcare/learning centers, bookkeeping, and workshops, among others.  
 Collaborative project: Beginning in 2016 and continuing in 2017ff, CCA conducted survey among residents of a 10-square block radius in East Mt. Airy - aimed at organizing "Children of Pennsylvania Pre-K and Afterschool STEM education Program" for children of this neighborhood. This project will be housed at CCA's 6721-23 Musgrave Street property, currently under rehabilitation. The children of Pennsylvania project is scheduled to open this summer, 2017.

 Applied Poverty Research: Since 1998, CCA conducts empirical poverty research as a result of practical projects among low-wealth populations. In 2016 and continuing in 2017ff, CCA conducted survey among residents of a 10-square block radius in East Mt. Airy - aimed at organizing a "Children of Pennsylvania Pre-K and Afterschool STEM education program" for children of this neighborhood. This project is scheduled to open in summer 2017. CCA further assisted Faith Immanuel Lutheran Church in collaboration with Yeadon (Delaware County) Mayor's office, to add a STEM component to Faith Immanuel Daycare and Afterschool program.

 Collaboration: CCA owns a property at 6721-23 Musgrave Street in Philadelphia. Kingdom Builders, Meaning of Life and a number of entities and individuals provided money, labor, and other items to rehab this property - aimed at housing the above described STEM (science, technology, engineering and mathematics) pilot project and CCA offices, among other uses. Further, Called To Serve CDC has secured 100 computers from Susquehanna International Group (SIG) for this project. Other entities have also expressed interests in helping to complete the rehabilitation this spring/summer and donate equipment for this project.

1. Community Capital Advisors (CCA) provided various forms of technical assistance to the above listed organizations, including business plans, project designs, fundraising advise, STEM education program development and training, and collaboration, among others.

2. Membership dues listed under Statement of Revenue (Form 990) refer to board members' voluntary contributions, not required dues.

3. CCA retains a number of policies prepared by the law offices the late Jack C. Briscoe, Esq - CCA's former board chair (deceased in 2014). These policies include non-discrimination, conflict of interest, whistle-blower, executives and management, board and committees, among others. Dr. Tom Gemmill, DVM was elected as new board chair on Monday, January 16, 2017.

4 CCA did about \$53,000 rehab work on its property at 6721-23 Musgrave Street property. This amount came in various forms, including monetary, materials, and labor.

5. CCA provided technical assistance to Eternal Life Missionary Baptist Church in Southwest Philadelphia to package a mortgage loan and facilitated negotiation between Eternal Life and mortgage company. CCA's technical support was in part responsible for buying this property 30% below asking price - enabling the church to pay \$31,000 cash instead of \$45,000 mortgage. The market value of the property is near \$160,000.
