CCA is the led partner and coordinator of the project because of our expertise and 20-plus years experience in organizing STEM education and CDFI projects.
- CCA further provided bro pono services to a number of nonprofits in the 5-county Philadelphia region in 2017.
- CCA conducted CDFI and STEM education related workshops during this period.
