Our current projects include the Liberia Institute for Girls - Todee (LIG) in Liberia - www.universityoftodee.org, and Compassion Community Ventures Fund in Philadelphia, PA.

Technical Assistance: CCA is spearheading the Liberia Institute for Girls - Todee (LIG) in partnership with Thadeaus Stevens College of Technology (PA) - www.stevenscollege.edu, Earth Forward Group (CT) - www.earthforwardgroup.com, and Curtlington University (Liberia) - http://www.cu.edu.lr/. The mission of the LIG project is to "Teach a Girl to Fish" - by aligning her education with STEM careers and a habit of health, encourage her to strive for gender-parity blended with the medicine of compassion, and connect her with exemplary global women leadership. The LIG project seeks to leapfrog a cluster of Liberian young women and girls in the Todee region of Liberia into the fast-paced, information-driven, knowledge economy; meanwhile, enhancing small enterprise development in the region as a catalyst for sustainable development.

Technical Assistance (PA): In 2018, CCA provided various types of technical assistance to a number of community-based groups, including Faith Immanuel Lutheran Church and All For All Agency in East Lansdowne - www.afaagency.org; Multicultural Community Family Services in Upper Darby - www.multiculturalcommunityfamilyservices.org; and Called To Serve CDC in North Philadelphia - www.calledtoservecdc.org, among others. CCA provided project designs and business plans, grant writing assistance/training, program and financial statements evaluation, among others. In many ways, these community organizations have become what we call CCA-affiliated entities.

Collaboration: CCA partnered with financial institutions and community organization on a number of emerging and existing projects, including Compassion Community Ventures (CCV). The CCV is being organized as an in-house community development ventures capital, aimed in part, at supporting CCA's technical assistance and collaborative projects in the Mid-Atlantic region. The CCV will eventually wean CCA from relying on pro bono services from the organization's technocrats and external grant supports. The CCV has the potential of harnessing the power of the community development financial institutions (CDFI) industry not only to support CCA work, but also advance economic and small enterprise development activities of grassroots organizations.
