This mission may be described as assisting women and underserved markets to increase their equity stakes or shares of socioeconomic wealth in the broader economy. The pillar of our mission is Women Capital International (WCI), an emerging CDFI (community development financial institution) supporting women-led small enterprise development in low-wealth markets.

Women Capital International (WCI) is an emerging CDFI (community development financial institution) as defined by the U.S. Treasury Department's CDFI fund (See www.cdfifund.gov). The WCI project aimed at becoming a pivotal pillar that support Community Capital Advisors (CCA) revised mission to "Teach a Girl to Fish," as well as supporting CCA's partnership projects and enhancing the organization technical assistance.

Our progress on organizing so far including, organizing a WCI community around the formation of the fund, developing a 45-page business plan, assembling a high-quality women-led leadership, including board of directors, credit & investment committee, and management team, and raising seed monies for legalization and certification with PA Departments of State and Banking, respectively. Upon completion of legalization and certification in 2020, the WCI will begin the long road of Phase-I and subsequent capitalization, commencement of operation and certification with the U.S. Treasury Department's CDFI fund.

Technical Assistance: CCA provided technical assistance to varying community organizations in the 5-county Philadelphia region. In addition to CCA-affiliated organizations, including People for People and Called to Served in Philadelphia, and Faith Immanuel Lutheran & AFA Agency, Multicultural Community Family Services, CCA assisted a number of new groups with business plans and project development, among others.

Partnership/collaborative projects: CCA's continues to participate or collaborate with other partners, including Earth Forward Group (EFG), Stevens College of Technology and others on the Liberia Institute for Girls - Todee (LIG) project - www.universityoftodee.org. CCA is also collaborating with EFG, Called to Served CDC and others on a potential Children of Pennsylvania neighborhood STEM education projects in the 5-county Philadelphia, PA region. Our Musgrave Street project is a pilot under the aegis of the Children of Pennsylvania collaborative.
