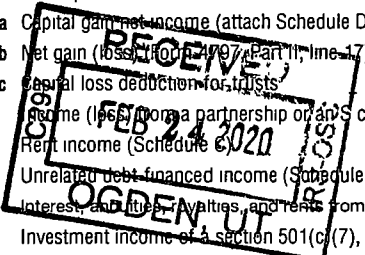

Repeal of Section 512(a)(7) on Part III, Line 34 of the Form 990-T:

Due to the implementation of The Taxpayer Certainty and Disaster Relief Act of 2019 (The Act), parking expenses recorded as UBIT under guidance of the TCJA Section 512(a)(7) has been repealed.
