This unique Trauma-Informed approach recognizes the mental and emotional barriers that can prevent individuals from finding sustainable educational, economic, and personal success. In 2018 the ERC assisted 226 students, 70 individuals were placed in jobs, and 33 clients enrolled in ESOL classes. The majority of the students live at the poverty level.

The Health & Wellness program offers free health screenings in conjunction with the Food, Clothing and Fresh Produce Distribution. There were 805 health screenings provided to attendees of the distribution. The program provided health information, wellness classes and cooking demonstration to promote health and nutrition.
