3. The Board of Directors of the Corporation wish to honor its founder by renaming the Corporation

The following sections of the Articles are hereby amended pursuant to the unanimous approval of the Corporation's Board of Directors as follows:

The name of the Corporation is hereby amended to **The Pete C. Garcia Victoria Foundation, Inc.** All references to **The Victoria Foundation, Inc.** and to "**Corporation**" shall hereinafter be to **The Pete C. Garcia Victoria Foundation, Inc.**
