OUR HIGH IMPACT MENTORING PROGRAMS ARE DELIVERED BY VOLUNTEERS. THE IRS DOES NOT ALLOW THE REPORTING OF THE VALUE OF THESE VOLUNTEER-PROVIDED SERVICES IN OUR FINANCIAL STATEMENTS, BUT THESE SERVICES ARE CRITICAL TO THE BIG BROTHERS BIG SISTERS OF COLORADO MENTORING PROGRAM OPERATIONS. IN 2019, OUR VOLUNTEERS PROVIDED AN ESTIMATED 89,993 VOLUNTEER MENTORING HOURS VALUED AT APPROXIMATELY \$2,336,218 (I.E. \$25.96/HOUR, INDEPENDENT SECTOR). THIS SIGNIFICANT VALUE RESULTS IN LOWER ADMINISTRATIVE/FUNDRAISING RELATED EXPENSE PERCENTAGES THAN REFLECTED IN FORM 990, PART IX. WHEN THE REPORTED PROGRAM RELATED EXPENSES ARE COMBINED WITH THIS VOLUNTEER-PROVIDED ADDED VALUE, OUR PROGRAM RELATED EXPENSES EQUAL 83% OF OUR TOTAL EXPENDITURES. HIGHER RETURN ON INVESTMENT. FOR EVERY DOLLAR INVESTED IN THE ORGANIZATION, AN ADDITIONAL \$.68 IN VOLUNTEER VALUE IS ADDED. THE TRUE VOLUNTEER CONTRIBUTION IS WELL OVER THIS AMOUNT SINCE VOLUNTEER HOURS DO NOT ACCOUNT FOR THE SIGNIFICANT ANNUAL INVESTMENT BY EACH MENTOR IN GAS, FOOD, ENTERTAINMENT, ETC. PROGRAM - PROVIDED ONE-TO-ONE MENTORING FOR 1,615 YOUTH - CELEBRATED 56 LITTLES WHO GRADUATED FROM HIGH SCHOOL IN 2019, MANY ARE THE FIRST IN THEIR FAMILY TO REACH THIS MILESTONE - FORMED A CENTENNIAL COUNCIL TO SUPPORT OUR AGENCY'S CENTENNIAL ACTIVITIES, WHILE ALSO ENGAGING COMMUNITY STAKEHOLDERS AND ALUMNI BIGS AND LITTLES. THE COUNCIL WAS MADE UP OF OVER 40 CURRENT AND ALUMNI BIGS, LITTLES, BOARD MEMBERS, DONORS, CORPORATE PARTNERS AND STAFF FOCUSED ON CENTENNIAL OUTREACH, MARKETING, FUNDRAISING, GALA AND HISTORY - OFFERED OVER 120 ORIENTATIONS, WORKSHOPS AND TRAININGS FOR MENTORS. ALSO PROVIDED 175 BACKPACKS WITH SCHOOL SUPPLIES AND MORE THAN 100 RTD BUS PASSES, ADOPTED 55 FAMILIES DURING THE HOLIDAYS, AND MADE OVER 270 RESOURCE REFERRALS FOR CLOTHES, MEDICAL CARE, COUNSELING, FURNITURE, ETC. THESE RESOURCES KEEP MATCHES OPEN, KEEP FAMILIES ENGAGED AND CONNECTED AND SUPPORTING THE MENTOR - SUCCESSFULLY TRANSITIONED FROM OUR TRADITIONAL BOWLING FOR KIDS' SAKE EVENT TO OUR INAUGURAL TOPGOLF FOR KIDS' SAKE EVENT, EXCEEDING OUR FUNDRAISING GOAL WITH OVER 600 ATTENDEES - RECOGNIZED BY THE BETTER BUSINESS BUREAU AS A 2018 CHARITY OF THE MONTH DUE TO QUALITY AND TRANSPARENCY.
