We took 253 children on overnight camping trips to various campgrounds. On each camping trip there were Bible lessons that were taught to the kids.

The program consists of small group Bible studies, leadership training, hiring interns, helping pay for college, and helping to provide funding for full-time staff from the community. We had an average of 182 kids per week in Bible study/discipleship relationship with staff, 11 kids in the beginning stages of the leadership training, 4 that work as interns, 5 students we are helping to pay for their college and 1 full time staff member that was partially funded through this part of our ministry.
