OUTCOMES EXCEED NATIONAL BENCHMARKS FOR SIMILAR POPULATIONS AND INCLUDED: TRANSITIONING TO STABLE HOUSING (77.4% VS. 68% STATEWIDE); HIGH SCHOOL COMPLETION OR RE-ENROLLMENT AND PROGRESS TOWARD GRADUATION (76.4% VS. 65% STATEWIDE); AND EMPLOYMENT (53.7% VS. 44% STATEWIDE).
