THE ORGANIZATION RECRUITED FOUR SCHOOLS TO PARTICIPATE IN A PILOT PROGRAM TO MEASURE THE IMPACT OF FOCUSED FUNDING ON HIGHER RISK STUDENTS. THIS PILOT PROGRAM WAS DESIGNED AND CONDUCTED IN PARTNERSHIP WITH THE OFFICE OF SUPERINTENDENT OF PUBLIC INSTRUCTION (OSPI). THE SCHOOLS WERE SELECTED FROM ACROSS THE STATE AND VARIED IN SIZE FROM LARGE TO SMALL SCHOOLS. THE SCHOOLS MEASURED STUDENT PROGRESS ON ATTENDANCE, COURSE SUCCESS AND SCHOOL ENGAGEMENT. STUDENTS WERE SELECTED BASED ON 8TH GRADE DATA INDICATING ISSUES IN ONE OR MORE AREAS (ATTENDANCE, GPA, SCHOOL ENGAGEMENT). EACH SCHOOL RECEIVED AN ADDITIONAL \$5,000 TO CREATE A STRONG NETWORK OF SUPPORT FOR STUDENTS TO SUCCEED IN THEIR FRESHMAN YEAR AND BE ON TRACK TO GRADUATE ON TIME.
