

Pursuant to the provisions of the Minnesota Nonprofit Corporation Act, Minnesota Statutes, Chapter 317A, the following Restated Articles of Incorporation are hereby adopted. All other previously restated articles of Incorporation and articles of amendment are hereby superseded in their entirety.

ARTICLE I

Name

The name of this corporation shall be Literacy Minnesota.

ARTICLE II

Registered Office

The corporation's registered office shall be in 700 Raymond Avenue, Suite 180, St. Paul, MN 55114-1780.

ARTICLE III

Duration

The corporation's duration shall be perpetual.

ARTICLE IV

Purposes

The corporation is organized exclusively for charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 as amended, and in furtherance thereof the corporation shall primarily be engaged in (1) literacy instruction for adults and children, together with any related activities such as curriculum and technology tools

and resources, (2) providing expertise, support and training to other organizations in their provision of literacy services and (3) the promotion and encouragement of such instruction and support services at local, regional, statewide and national levels.

No substantial part of the activities of the corporation shall be devoted to attempting to influence legislation by propaganda or otherwise and the corporation shall not directly or indirectly participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Further, the corporation shall not engage in activities which would characterize it as an "action" organization as defined in the federal income tax regulation 1.501(c)(3). Notwithstanding any other provision of these Restated Articles of Incorporation, the corporation shall not carry on any activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 as amended, or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 as amended.

ARTICLE V

Members

There shall be more than one class of members. Classes, voting rights and qualifications for membership in the corporation shall be further defined in the Bylaws.

No member shall have any personal liability for corporate obligations.

No member shall have any cumulative voting rights in connection with the election of directors.

ARTICLE VI

No Capital Stock

The corporation shall have no capital stock.

ARTICLE VII

Directors

The business and affairs of the corporation shall be managed by or under the direction of its Board of Directors, who shall be elected in the manner provided in the Bylaws of the corporation. The number, qualifications, terms of office and other conditions for directors also shall be as provided in the Bylaws.

ARTICLE VIII

No Pecuniary Gain

The corporation shall not afford pecuniary gain, incidentally or otherwise to its members, directors or officers and no part of the net income or net earnings of the corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article IV hereof.

ARTICLE IX

Directors and Officers Not Liable

No director or officer of the corporation, as such shall have personal liability to any extent for the acts, debts, liabilities or obligations of the corporation, and each director and officer shall receive indemnification from the corporation against certain liabilities and expenses in the manner provided in the Bylaws of the corporation.

ARTICLE X

Dissolution

Upon the dissolution of the corporation the Board of Directors shall, after paying or making provision for the payment of all the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational or other purposes as shall at the time qualify as an exempt organization or organizations under section 501(c)(3) of the Internal Revenue Code as the Board of Directors

shall determine. Any of such assets not so disposed of shall be disposed of by the District Court of the county in which the principal office of the corporation is then located, exclusively in a manner which will be considered as an exempt purpose or purposes.

ARTICLE XI

Effective Date

The effective date of these Restated Articles of Incorporation shall be January 1, 2020.
