THE COMMITTEE'S MAIN RESPONSIBILITIES ARE TO OVERSEE THE FINANCIAL PROCESSES OF THE ORGANIZATION, REVIEW THE MONTHLY FINANCIAL STATEMENTS, OVERSEE THE AUDIT AND FORM 990 PREPARATION PROCESS, AND REPORT FINANCIAL PROGRESS TO THE BOARD OF DIRECTORS ON A MONTHLY BASIS.
