CHILDREN'S HUNGER ALLIANCE DIRECTLY PROVIDES MEALS TO LOW INCOME CHILDREN IN HOME BASED CHILDCARE, CHILDCARE CENTERS, AFTER SCHOOL PROGRAMS AND SUMMER FOOD SERVICE PROGRAMS.
