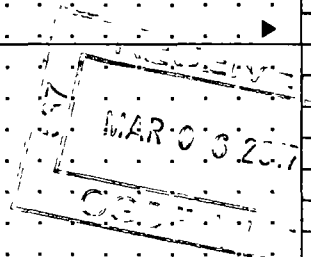

Our organization is incorporated to deliver meals, at cost, to people who are homebound, ill, unable to cook for themselves, or who have special dietary needs. A secondary purpose is to enable persons to live in their own homes as long as possible before entering a nursing or retirement home.

During the year 2016, we have served between 39 and 46 persons daily, five days a week. A total of 9,370 hot meals and 6,887 cold meals for a total of 16,257. In 2016 our subsidies amounted to \$1,524.
