Cradle of Hope encourages life by providing financial and material assistance to women and babies in crisis especially those women who might not choose life because of financial pressures.

Rent/Mortgage assistance for pregnant women and mothers with infants up to four months of age: Homelessness is avoided and mothers are able to maintain doctor-ordered bedrest because of Cradle of Hope's assistance with rent/mortgage payments In 2017, 411 women were assisted with a total of \$425,077 for rent/mortgage assistance when pregnancy related financial challenges threatened their stability. This critical program has immeasurable health benefits for both mother and child by providing shelter and promoting full term pregnancies. Maguire Agency donated use of their facilities for Cradle of Hope to operate for a portion of the year.

4b (Code:) (Expenses \$ 112,634 including grants of \$ 90,991) (Revenue \$)
Cradle of Hope's Safe Slumber Program: The probability of infant mortality is lessened due to Cradle of Hope's Safe Slumber Program which distributed 1,493 portable cribs in 2017. In addition to the portable cribs, each client receives a safe sleep sheet set and safe sleep information so each client can ensure a safe environment for their baby. Mothers benefit from the program because their babies are secure in a safe environment which reduces stress and empowers them to become hopeful about their future. Maguire Agency donated use of their facilities for Cradle of Hope to operate for a portion of the year.

4c (Code:) (Expenses \$ 28,158 including grants of \$ 22,747) (Revenue \$)
The two programs listed above are our most significant programs. The remainder of our program funding supports the following needs: Utilities, Medical Costs, Child Care, Wellness Baskets, and Transportation. Maguire Agency donated use of their facilities for Cradle of Hope to operate for a portion of the year.
