LEAD YOUTH CARE SPECIALISTS POSITIONS AND A COMPLIANCE ADMINISTRATOR POSITION WERE CREATED. A NEW SHELTER COORDINATOR WAS HIRED - PROMOTION FROM WITHIN THE ORGANIZATION.
