	The Employment Training Center (ETC) provides pathways out of poverty to lasting economic independence for San Francisco's low-income youth and young adults with histories of incarceration, homelessness, substance abuse, and other major barriers to employment. For over 35 years, Asian Neighborhood Designs (AND) Employment Training Center (ETC) has successfully trained at-risk, low-income youth and young adults in the green construction field to gain vital life and employment skills and achieve self-sufficiency. Each year, up to 60 graduates gain comprehensive skills in construction and carpentry, and receive basic education on topics such as history and mathematics, as well as high school equivalency or GED preparation. Our program also works to diversify the field of construction by including women and serves 90% people of color.
