The exemptions are subject to periodic review by the federal and state taxing authorities and management is confident that A N D continues to satisfy all federal and state statutes in order to qualify for continued tax exemption status. A N D may periodically receive unrelated business income (such as sublease rental income) requiring A N D to file separate tax returns under federal and state statutes. Under such conditions, A N D calculates and accrues the applicable taxes.
