Explanation: This organization is 100% volunteer, staffed entirely by volunteers who are retired, with the exception of the volunteer responsible for book keeping, who has a 50-60 hour per week job on which she depends for her income. She became overwhelmed with her real employment and neglected her volunteer responsibilities to the organization, including the timely filing of the 990. The former Treasurer, who previously tracked deadlines for filings, no longer volunteers for the organization. The organization will now be looking for another volunteer willing and able to take over accounting and tax filing duties, or a paid accountant. In the event that penalties are assessed by the Internal Revenue Service, the volunteer responsible for the late filings will seek to reimburse the organization for those penalties, although it will be a hardship. We sincerely hope that the Internal Revenue Service will appreciate the dedication (but also the limitations) of the volunteers who have been serving meals to home bound seniors continuously for 35 years, without benefit of paid staff or government funding. Food cost comprises more than 95% of our operating expenses and, despite our limited administrative overhead, this is the first time that the 990s have been filed late. Thank you very much for your consideration.
