Childcare - United Neighborhood Centers provides child care services to school age children at three different sites in Lackawanna County. In addition, two of UNC's Child Care sites include a preschool program. The Green Ridge Center has attained a Star 3 Rating from the Commonwealth of Pennsylvania and is currently working toward a Star 4 rating. The Progressive and Bellevue Child Care programs have attained a Star 2 Rating and are working toward a Star 3 Rating. These Centers serve primarily low income, culturally and racially diverse families. As a part of our childcare services we provide daily transportation to and from most schools in the greater Scranton area.

Aging - United Neighborhood Centers provides services to Senior Citizens in Lackawanna County through four community based sites, two in Scranton, the West Side and South Side Centers, one in Jessup, the Mid Valley Center and one in the city of Carbondale. Each of these Centers provides a hot noon meal as well as socialization, recreational and health promotion programs throughout the day. Special events such as Holiday parties and bus trips also offer additional socialization opportunities.

Project Hope - Project Hope is a summer day camp program which serves between 300 and 400 low income children from throughout Lackawanna County at our camp site at Camp Kelly in Tunkhannock, PA. UNC provides bus transportation from sites throughout Lackawanna County to the camp site for four weeks each summer. Campers take part in regular recreation activities including sports, swimming, archery, arts and crafts and nature programs. In addition, through a cooperative agreement with the Scranton School District we offer fun academic programs, which allow children to sharpen their academic skills over the summer months.
