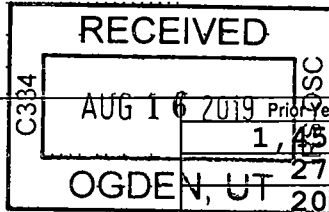

THE HOMELESS SERVICES PROGRAM PROVIDES SHELTER AND SUPPORTIVE SERVICES TO HOMELESS WOMEN AND THEIR FAMILIES. RESIDENTS RECEIVE COUNSELING, LIFE SKILLS INSTRUCTION, CASE MANAGEMENT AND CHILD CARE AS THEY WORK TO MOVE INTO PERMANENT HOUSING. OVER 100 FAMILIES WERE SERVED IN 2018. THIS PROGRAM ALSO OPERATES A WALK-IN SITE FOR COORDINATED ENTRY, WHERE INDIVIDUAL AND FAMILIES EXPERIENCING HOMELESSNESS CAN BE ASSESSED AND REFERRED TO PROVIDERS ACROSS THE LEHIGH VALLEY FOR SHELTER, HOUSING AND SERVICES.

SHARING THE CARING ADULT DAY SERVICES PROVIDES STIMULATING, QUALITY CARE TO THOSE SUFFERING FROM THE PHYSICAL AND/OR MENTAL PROBLEMS OF AGING, SUCH AS DEMENTIA, STROKE, FRAILTY, OR OTHER AILMENTS REQUIRING CARE. THIS PROGRAM PROVIDES SERVICE TO BOTH OLDER ADULTS, PREVENTING PREMATURE PLACEMENT IN A NURSING HOME, AND TO CAREGIVERS, GIVING THEM THE ABILITY TO WORK OR DEAL WITH OTHER RESPONSIBILITIES.
