EXAMPLES OF SUCH PROGRAMS AND SERVICES INCLUDE PRE-K READINESS, AFTER SCHOOL ENRICHMENT (SEE 4B BELOW), TECHNOLOGY EDUCATION, JOB READINESS SKILLS, SEVERAL FITNESS CLASSES SPANNING ACROSS ALL AGE GROUPS, SWIM LESSONS, ORGANIZED PHYSICAL EDUCATION GAMES AND SPORTS, NUTRITION THROUGH GOVERNMENT FOOD PROGRAMS (CACFP DURING THE SCHOOL YEAR AND SFSP DURING THE SUMMER), AND ANNUAL SPECIAL EVENTS THAT INCLUDE THE 3-ON-3 BASKETBALL TOURNAMENT, 5K RACE, GOLF OUTING, AND DODGEBALL TOURNAMENT. FUNDING STREAMS HAVE REMAINED CONSISTENT FOR AFTER SCHOOL AND SUMMER PROGRAMMING AT THE TITUSVILLE YMCA. AS PART OF THE 21ST CENTURY COMMUNITY LEARNING CENTER (CCLC) INITIATIVE, THE TITUSVILLE YMCA SERVES AS THE GRANTEE FOR AN ENRICHMENT PROGRAM FOR CHILDREN IN GRADES 1-8 AND THEIR FAMILIES, AGAIN SUBSCRIBING TO THE HOLISTIC APPROACH IN AFFECTING POSITIVE OUTCOMES. THE 21ST CCLC PROGRAM TARGETS AT-RISK YOUTH, BUT IS OPEN TO ALL CHILDREN WHO WISH TO PARTAKE IN THE VARIETY OF ENRICHMENT COMPONENTS OFFERED. BY PROMOTING A HETEROGENEOUS ATMOSPHERE, THESE YOUTH LEARN LIFE LESSONS FROM EACH OTHER TO COMPLEMENT THE ACTIVITIES LED BY A DIVERSIFIED PROFESSIONAL STAFF TO INCLUDE CERTIFIED TEACHERS, HUMAN SERVICES SPECIALISTS, PHYSICAL EDUCATION EXPERTS, AND NUTRITIONISTS. OVER 1,000 CHILDREN HAVE BEEN SERVED SINCE 2003 THROUGH THE TITUSVILLE YMCA'S VENERABLE AFTER SCHOOL AND SUMMER ENRICHMENT PROGRAMS.
