YEAR, WC&S PROVIDES LIFESAVING SERVICES-INCLUDING COUNSELING, ADVOCACY, AND EMERGENCY RESPONSE-TO 7,500 ADULTS EXPERIENCING INTIMATE PARTNER VIOLENCE AND THEIR CHILDREN IN 2013, WOMEN'S CENTER &
